ISO27001 Overview Information Security – The Facts

ISO 27001:2005 is an Information Security certification. Information Security defines Information, as an asset, which adds value to an organization and consequently needs to be suitably protected. It can be printed or written on paper, stored electronically, transmitted by post or using electronic means, shown on films, or spoken in conversation.

Information security protects information from a wide range of threats in order to ensure business continuity, minimize business damage and maximize return on investments and business opportunities.

Information security is achieved by implementing a suitable set of controls, which could be policies, practices, procedures, organizational structures and software functions. These controls need to be established to ensure that the specific security objectives of the organization are met.

- Continuous Improvement – As part of the ISO process, 2sms now discuss potential improvements to all areas of our service on a weekly basis, this includes the discussion of suggestion provided by customers and enhancements put forward by our customer support and IT Departments.
